In general, with 86 responses from only families, the majority of responses were opposed to a mask mandate for teachers and staff members, and in favor of a shortened quarantine. Fifty percent indicated that they would not remove their students from TRM if masks were mandated. At this time a majority of schools in the Sherburne county area have decided to not require masks and opted for a shortened quarantine.
